A re-letting fee will also be payable if a new tenant is found prior to the expiration of the fixed term lease. Elders Real Estate will undertake means to re-let the property as soon as possible after the abandonment and will take all reasonable steps, keeping in mind the market conditions at the time, to accomplish such re-letting. We wish to stress that the Tenancy Agreement has **not** ceased and the tenant should retain the keys to the property as the tenant is still responsible for internal and external maintenance until the new tenancy commences.

Once the keys have been returned to Elders Real Estate with vacant possession, it is expected that the property is returned in the same condition as per commencement of tenancy. The property cannot not be re-let unless all cleaning, repairs & pest fumigation have been attended to. Should further works be required this will be deducted from the bond. Do not disconnect electricity until final inspection is done. ANY RECONNECTION FEE FOR CLEANING ETC. & ALL CLEANING, CARPET CLEANING & PEST FUMIGATION WILL BE AT THE TENANTS EXPENSE.
